## 4. FIRST AID MEASURES

**EYES:** Rinse out with plenty of clean water at once. Continue for at least ten minutes. Seek medical advice.

**SKIN:** Wash off immediately. If irritation persists seek medical advice.

**INGESTION:** Do not induce vomiting. Rinse out mouth and drink plenty of milk or water, unless the patient is unconscious. Seek medical attention.

## 5. FIRE FIGHTING MEASURES

Not flammable. If involved in a general fire, produces carbon oxides. Incomplete combustion will result in more complex compounds. Breathing apparatus is required no restriction on extinguishing medium.

## 6. ACCIDENTAL RELEASE MEASURES

Small spillages can be washed away with water.

Larger spillages are mixed with sand or earth and removed in a suitable container for transfer to an approved tip. Alternatively flush to drain with copious quantities of water.

Operators are recommended to wear rubber gloves. Store in dry conditions away from foodstuffs. Keep lid firmly on container. Keep out of reach of children.
